On February 10, 2017, the Board of Directors of the Company approved the following matters:

- (a) amendment of the date, time and venue of the Company's annual meeting of the stockholders (as set forth in Section 1 of Article II of the Company's By-Laws), as follows: (i) the date and time of the Company's annual meeting of the stockholders will be changed from "the first Saturday of April of every year, at 4 o'clock in the afternoon" to "the 15th of July each year, if falls on Saturday, Sunday or holiday, on the following business day, at any time of the day"; and (ii) the venue of the Company's annual meeting of the stockholders will be changed from "the principal office of the corporation" to "any place where the Company has business operations or anywhere within Metro Manila"; and
- (b) amendment of the venue of the Company's special meeting of the stockholders (as set forth in Section 2 of Article II of the Company's By-Laws) from "the principal office of the corporation" to "any place where the corporation has business operations or anywhere within Metro Manila".
